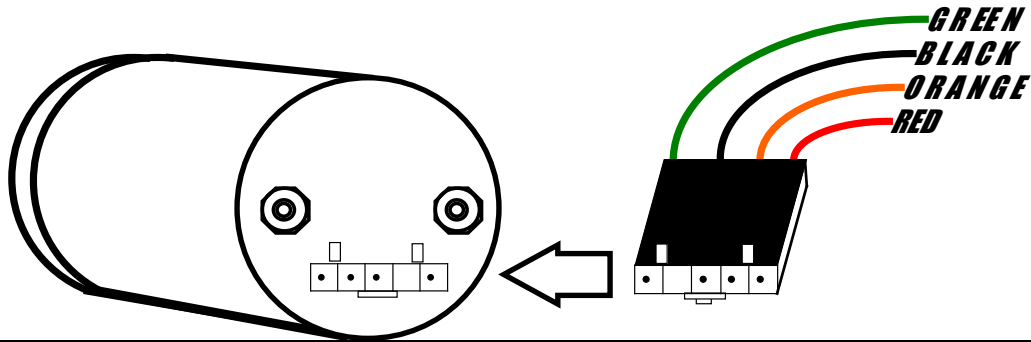


Boost Gauge Instructions
 Digital Series ONLY



Wire Color Code			
Black	Engine Ground	Orange	Optional Headlamp 12v (+)
Red	12v Ignition Switch (+)	Green	Sender wire from digital boost sensor

Warning: Vacuum line should not be near anything hot or any moving engine parts. We recommend that you secure the hose with zip ties.

1. Disconnect the negative battery cable.
2. Run the tube from the Boost sensor to the t-fitting. **Note:** Make sure the vacuum line is not pinched.
3. Cut any vacuum line and attach the T-Fitting and the newly run vacuum line to the end of the T-Fitting that has the brass piece for air PSI restriction. Connect the two cut ends to the remaining sides of the t-fitting. If a line is not available to cut and add the t-fitting there may be a capped off end on the intake manifold that you can connect to. If the end is also not available it will be necessary to drill a hole and thread in a vacuum line adapter.
4. Connect the red wire of the gauge and the vacuum sensor to 12 volt switched source. When wiring this connection install a 3 amp fuse within 20 inches of the source. For easy installation in the fuse panel you can get an “add a circuit” which looks like a fuse with an additional wire attached; this is available at a local auto parts store.
5. The orange wire needs to be connected to the positive side of the parking lights. The easiest way is to tap into the wire on the parking lights assembly or you can also connect it at the headlamp switch. This is optional. If it is not hooked up then the gauge will simply not dim when you turn on your headlamps.
6. Connect the green wire to the white wire of the boost sensor.
7. Connect the black wires to any ground connection or you can run a wire to the negative side of the battery.
8. Reconnect the negative battery cable.
